First Efficiency Bar Examination for the Service of Professions Supplementary to Medicine who are in Grade III in the Ministry of Health – (2022 - 1st Term)

It is hereby notified that the Efficiency bar Examination which should be passed by **Pharmacists, Physiotherapists, Occupational Therapists, Radiographers and Medical Laboratory Technologists** belonging to the Paramedical service (MT - 06 - 2016) who are in Grade III within three years from the date of appointment to Grade III will be held on in Sinhala, Tamil and English medium. The date, venue and the time of the examination will be notified along with the admission card.

02. Qualifications

The officers who have been appointed to **Pharmacists, Physiotherapists, Occupational Therapists, Radiographers and Medical Laboratory Technologists (MT – 06- 2016) in Grade III** and not yet completed this examination are only eligible to apply for this examination.

03. Applications

Applications prepared by the candidates as per specimen appended to this letter should be sent under Registered Cover to reach the Director (Examinations), "Suwasiripaya", No.385, Ven. Baddegama Wimalawansa Thero Mawatha, Colombo 10 on or before **2022.06.30** through their Heads of Institutions. The Head of Division should certify the accuracy of contents in each application. Two self-addressed envelopes (Candidates can write their official or private address) **in the size of 9" x 4" inches, affixed with stamps to the value of Rs. 45.00 should be sent along with the application.** Applications which are received late, incomplete or inaccurate will be rejected.

Note: The application should be prepared using an A4 paper based on the specimen form of application so as to accommodate from 01 to 04 on the first page and from 05 to 09 on the second page. Applications which do not confirm to above will be rejected without any information.

04. Examination fees

- i. Candidates who sit the examination for the first time need not pay examination fees. However, in every subsequent sitting they should affix stamps to the value of Rs. 25/= per subject in the stamps cage provided for in the application and cancel same by placing their signature and the date.
- ii. The fees once paid will not be refunded or transferred to other examinations under any circumstances.

05. Admission to the Examination

- I Candidates whose applications have been accepted will be issued with Admission Cards. They should duly complete and submit same to the Supervisor at the Examination center. Otherwise, they will not be allowed to sit the examination.
- II Candidates should prove their identity to the Supervisor at the examination hall. For this purpose one of the following documents will be accepted.
 - (a) National Identity Card
 - (b) A formal Identity card issued by the Ministry of Health or Relevant institution
 - (c) A Valid Driving License
 - (d) A Valid Passport

06. Scheme of the Examination

This Efficiency Bar examination consists of two question papers which are essay type questions in Establishments Code & Procedural Rules Rules and Financial Regulations. They can complete the examination at once or several occasions. At the first attempt officers should apply for all relevant subjects.

07. Syllabus

07.1 Establishments Code & Procedure Rules

The question paper consists of 08 essay type questions and candidates are required to answer any 05 questions out of them. Duration is 3 hours for each question paper and each paper will receive 100 marks. Applicants shall secure minimum of 40% marks to have pass in the examination.

- **Establishments Code and Public Administration Circulars on officers' performances evaluation will be based on following chapters.**

Chapter IV - Monthly payments, Temporary status, Permanent status and pension ability.


