PREPARATION FOR COUNTRY PAPER

Successful applicants will be required to prepare a country paper
A ten-minute Power Point presentation will be required from each country during the programme
The country paper must include participant's expectations and plan of action for further collaboration

ENTRY REQUIREMENT

1. Medical degree or degree in health-related science discipline
2. 3 years or more work experience in public health
3. Age between 26 to 50 years old
4. Good proficiency in English Language (written and spoken)
5. Nominated by the government
6. Medically fit
7. Valid international passport (6 months)

SUCCESSFUL PARTICIPANTS

It is mandatory for all the MTCP participants to follow the Visa With Reference (VWR) application procedure. Wherever applicable, participants are advised to arrange for vaccination on their own prior to travel to Malaysia.

Expenditures on all visa-related fees, airport tax/airport user's charge, transit insurance, excess luggage, travel tax, transit fees, domestic passenger terminal fees, phone charges, private purchases, etc is to be borne by the participants.

Participants from yellow fever-endemic areas including diplomatic and official passport holders are required to take a mandatory vaccination for yellow fever at least ten (10) days prior to their departure for Malaysia and to produce a Yellow Fever Vaccination Certificate at the entry point in Malaysia.

APPLICATION GUIDELINES

Applications should be made using the prescribed MTCP forms available at:
https://mtcpcoms.kln.gov.my/mtcpcoms/online/list_course. MTCP application forms can also be obtained at nearest Malaysian Embassies in recipient countries.

All application forms must be duly completed and endorsed by the Ministry of Foreign Affairs or National Focal/Aid Coordinator Agency in the respective countries (the relevant ministry or agency responsible for the overall coordination of international technical assistance) and should be submitted ONLY through the diplomatic channel via Embassy of Malaysia in the respective countries.

INCOMPLETE AND/OR UNENDORSED FORMS WILL NOT BE PROCESSED.

Submitted application forms must be accompanied by the applicant's:

- Copy of Passport
- Passport sized coloured photo (3.5cm x 5cm)
- Medical Report

Only successful applicants will be notified.

Other information:

1. Allowances will only be paid on first day of the programme
2. The Government of Malaysia shall provide excursion economy air ticket to all MTCP participants from the capital city of the MTCP recipient country to Kuala Lumpur and return air ticket from Kuala Lumpur to the capital city of the MTCP recipient country.
3. Medical treatment is provided at government hospitals/clinics only and the expenses will be borne by the Government of Malaysia under the MTCP. In case of an emergency, participants are eligible to be admitted to government hospitals/clinics. Dental treatments are restricted to extraction and filling only.
