<p>About the Organizer</p>	<p>1. International Health Exchange and Cooperation Centre, National Health Commission, P.R. IHECC has organized several training programs related to Telemedicine, including Training course on Telemedicine for Morocco in 2019 (Off-line Training), and Training course on Telemedicine for Pakistan in 2022 (Online training), Trainees had been actively participated, and the training coursed had been well received by them.</p>
