About the Organizer	<p>1. International Health Exchange and Cooperation Centre, National Health Commission, P.R. China (IHECC) is an independent legal entity, directly led by NHC, specializes in international exchange and cooperation in the field of health. It is responsible for organizing research on the theory, policy and development strategy of international cooperation in the field of health and providing policy suggestions and technical advisory services on legislation, government decision-making and regulation planning. IHECC drafts operational regulations and technical specifications for international exchanges in health industry, undertakes international health assistance projects, carries out charity health cooperation projects both in and outside China, and strives to promote global cooperation for the development of health industry. The Center has been undertaking foreign aid training programs of MOFCOM for 17 years. It finished 81 programs, receiving almost 1,877 trainees from more than 92 countries and regions.</p> <p>2. IHECC has established the two principles of "training with the best resources" and "multi factors, multi benefits, whole links and long-term development", actively explored the remote training mode of foreign aid projects, and made full use of online conference system and video recording. This will enable health professionals from the Belt and Road countries participating in the foreign aid training program to know more about the pathway of health development, enhance mutual understanding and promote mutual learning, as well as achieve the goal of consultation, construction and sharing of a global community of health for all.</p> <p>3. IHECC attaches great importance to foreign aid training and has a rigorous organization, coordination and management mechanism. IHECC has carried out hundreds of health training programs in China, with profound technical and faculty resources, and the ability to leverage and integrate the forces of government, academia, and industry.</p> <p>4. IHECC is the leading unit of the B&R Health Industry Sustainable Development Alliance of the NHC, integrating domestic and international resources in the field of health, achieving harmonious development, and promoting China's health industry "go global", including medical imaging and ultrasound products and technologies. IHECC has long-term and good cooperation with relevant departments of National Health Commission, National Medical Products Administration, Beijing Union Medical College Hospital, and other medical institutions, and invite leaders of relevant departments of NHC, leaders of relevant departments of National Medical Products Administration, clinical experts in ultrasound and medical image from relevant medical institutions, to give lectures on training courses. IHECC held "Training Course on Medical Image for B&R Countries" successfully in 2018 and 2019, held "Training Course on Medical Diagnostic Technology for Democratic People's Republic of Korea" in 2019. In particular, since the COVID-19 pandemic, IHECC has successfully undertaken several online training courses, such as "Seminar on medical equipment usage and medical technology in China assisted hospitals for developing countries" "Global Public Health Governance" with good enrollment and excellent course design. Seminar Content	<p>This 14-day training course will be hold in Beijing, China. We specially invite leaders of relevant departments of NHC, leaders of relevant departments of National Medical Products Administration, and experts from Peking Union Medical College Hospital and other top hospitals to give lectures, and to participate in academic exchanges with participants from B&R countries. By using teaching and evaluation methods such as lectures, discussions, on-site visits, and pre and post training evaluations, we aim to improve participants' theoretical knowledge and practical skills in pharmaceutical supervision and industrial development cooperation, deepen participants' understanding of China's medical image products and technologies, establish an international cooperation platform of pharmaceutical supervision and industrial development cooperation between China and relevant B&R countries.</p> <p>The main courses of this training course include (1) public courses: Chinese National conditions and medical and health conditions; Development history of China's medical image industry; (2) Professional courses: China's pharmaceutical supervision system, current development status and advantages of the pharmaceutical industry, International cooperation of pharmaceutical industry, drug clinical trial supervision and management, medical device clinical trial supervision and management, drug registration and filing, drug production quality management, medical device product registration and filing, medical device production management, drug operation quality management, drug recall management, medical device operation and use management, adverse event handling and medical device recall system, etc. During the training, participants will be organized to visit " China-Hospeq 2023" related activities; visit the site activities of tertiary hospital, medical institutions and community health service centers in Beijing and other province, and having in-depth discussions and exchanges with relevant personnel. Cultural exchanges will also be arranged to enhance the friendship between people of different countries.</p>
