**Annual Transfers of Dental Surgeons 2020**  
**Recommendations for Annual Transfer of Dental Surgeons - 2020 (Stage II)**


The Recommendation list of above transfers published by me on dated 09/06/2020 (Ref No. D/DS/AT/164/2019 and dated 06/04/2020) is cancelled hereby, as the Health Service Committee of the Public Service Commission instructed to remove the transfer orders to the same station within two years by its letter No. HSC/TRA/DEN/14/08/2019, dated 08/10/2020.

Due to the amendments of number of transfers, based on the above instructions, the transfer list was redone. Removal of one transfer from chain of transfers, lead to amendment of numerous transfer orders. Thereby, a practically implementable transfer list with replacements is prepared by the transfer board.

The Health Service Committee instructed to forward the transfer list with the signature of the transfer board member of the Government Dental Surgeon's Association (GDSA). The GDSA initially did not agree to abide by the instruction of the Health Service Committee and requested time for them to negotiate with Health Service Committee. The GDSA agreed only on 10/02/2021, to redo the transfers as per the instructions of the Health Service Committee (Ref No. HSC/TRA/DEN/14/08/2019 dated 08/10/2020 and 27/10/2020) and hence the stage 2 recommendation list has been redone.

As per the paragraphs 210 and 211 of the procedure rules of the Public Service Commission the recommendation list is published herewith for the appeals, if any.

The appeals have to be forwarded on or before 27/04/2021 as per the instructions given in the letter No. D/DS/AT/164/2019, dated 06/08/2020 appeared in the website of the Ministry of Health on 09/06/2020.
