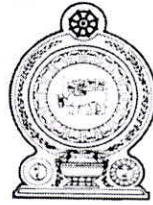

Annual Transfers of Dental Surgeons – 2022

Final Noted List for all transfers including SHO/HO posts for specialized units for period of 2 years, after considering the appeals received by 10th June 2022 on provisional noted list, Eligible Dental Surgeons list and the list of additional vacancies are published herewith.

The provisional noted list was revised based on the following decisions by the transfer board.

1. Dental Surgeons who were assigned posts from Annual transfer who have not reported to the station before 31.03.2018 were allowed to be "Considered Not Noted (CNN)"
2. Dental Surgeons who were assigned Special posts from Annual transfer who have not reported to the station before 31.03.2020 were allowed to be "Considered Not Noted (CNN)"
3. Dental Surgeons who have not reported to previous transfer orders were not noted, as previous transfer order stands and they are advised to report to their new station immediately.
4. Dental Surgeons who were Considered Not Noted and holding 4 year posts who requested to become Eligible were allowed to do so.
5. Community Dentistry trainees who completed post graduate training period this year at PGIM were noted.
6. A web based application has been developed and all Dental Surgeons are kindly requested to apply **only** through the online application which will be appeared on the official web site of

7. All Noted / Eligible officers who fulfill the requirements of selection criteria for Special Posts can apply for the given vacancies.
8. Dental Surgeons who will be selected for the special posts (SHO/HO posts) would have to serve directly under the supervision of the consultant of respective units. They are bound to do on call duties. The minimum period is 2 years.
 - Selection Criteria for HO Posts – Should be an Eligible officer and not have exceeded ten years (10) in the government Dental Services. Priority will be given to the officers who apply for the first time.
 - Selection Criteria for SHO Posts – Should have completed HO/SHO posts for a two year period in the relevant field within last eight (08) years. Priority will be given to the officers who apply for the first time.
9. Selection criteria approved by PSC will be applied for Regional Dental Surgeons, SHDO of National Dental Hospital – Colombo, Dental Surgeons position in Family Health Bureau, Health Promotion Bureau, National Cancer Control Programme, Training, Research & Surveillance units in IOH, Dental Therapist Training School Ministry of Health (Annexure I, Annexure I, Annexure III, and Annexure IV of Scheme of Transfers-Grade Dental Surgeons extraordinary gazette notification No. 1589/30 dated 2009/02/20 and subsequent regulations imposed by the public service commission). Proposed criteria for the Post of Forensic Medicine & Toxicology DS (Special Criteria Post) is attached in the Annexure VI for ^{PSC} your Approval. If there are no suitable qualified applicants, transfer board will recommend to fill the vacancy by most qualified applicant.

This call for application was published with the pending approval of Health Service Committee of Public Service Commission (PSC) to avoid the delay.
