**Appointing Senior Medical Laboratory Technologists to the laboratories.**

The meeting to discuss the above matter with the stakeholders was held at the DGHS office on 2<sup>nd</sup> of November 2019 with the chairmanship of DGHS. The meeting was concluded with the following decisions.

1. Senior Medical Laboratory Technologists should be appointed to each section in the hospitals where all four sections of laboratories are available (Haematology, Chemical pathology, Histopathology, Microbiology). This appointment should be given by a letter issued by the institutional head as an internal arrangement. The duties and responsibilities of Senior Medical Laboratory Technologists should be in accordance with the General Circular letter No.02-17/2006 dated on 20.01.2006.
2. The other hospital laboratories which function as a single laboratory without sections as mentioned above should have one Senior Medical Laboratory Technologist to the laboratory. The duties and responsibilities of Senior Medical Laboratory Technologists should be in accordance with the General Circular letter No.02-17/2006 dated on 20.01.2006.
